DELIBERATION

- Deliberation exists at the intersection between facts, values, and policy.
- It aims to bring citizens together to have productive, thoughtful conversations about issues impacting the public
- It requires *good process* to function appropriately
- Managing power dynamics in diverse groups is a key challenge

TOOLS

- All registrants received a Facilitator Booklet via e-mail
- This contains facilitator moves, advice on recruitment, and a copy of our ground rules

VALUE RANKING

- You'll be sent to small groups and asked to rank the following values from most important to leastimportant
 - o Freedom
 - Justice
 - Equity
 - o Community
 - Individual Responsibility
 - Security
 - Diversity
 - Sustainability
- Students will paste these into the chat and lead you through the activity. 15 minutes.

VALUE RANKING

- Can be a vital tool in setting the stage for your conversations
- Asking people to speak from their own experience and define what is important to them helps level the playing field
- Can also serve as a helpful tool when/if conversations get tense
 - "We did our value rankings earlier, which of these values do you think is coming into play right now? What might someone with different values say?"

EQUITY IN RECRUITY IN

- A focus on equity requires more than just a good conversation, it also requires you to focus on *who* is in the room
- Often there are numerous barriers for underrepresented populations to even show up!
- Especially in homogeneous areas like Fort Collins, a focusing on equity in recruitment is key

BARRIERS

- Did they receive an invite?
- Do they have the time?
- Can they get there?
- Do they have conflicting responsibilities?
- Do they feel like they can make a difference?
- Do they feel like they have enough information?

CPD BEST PRACTICES

- Offer multiple times/events if possible
- Offer childcare or children's activities
- Provide small stipends for participation
- Offer translation and interpretation services
- Recruit through various media
- Recruit through trusted stakeholders

- Who are the stakeholders in your community?
- What might prevent them from attending your event?
- How might you address those barriers?
- 15 minutes in breakout groups

EQUITY IN CONVERSATION

- Facilitators play an important role in modeling conversation behaviors
- Set ground rules/conversation norms
- Model good active listening
- Clarify the importance of both content and context experts
- Use facilitator tools/moves to invite participants into conversation

TEXPERTS

- Content v. context experts
- Facts and data are important, but shouldn't be the only drivers of our conversations
- Welcome and honor lived experience as expertise

GROUND RULES

- Be honest and respectful
- Listen to understand
- It's okay to disagree, but do so with curiosity, not hostility
- Be brief so everyone has a chance to participate
- Stay in learning mode

FACILITATOR MOVES

- Paraphrase for clarity
- Let the silence hang
- Bring in the empty chair
- Refer back to the ground rules

REFRAINING

"It sounds like you're concerned..."

"Reintroducing wolves in Colorado has to be one of the biggest examples of government overreach and environmentalism-gonewild that I've ever seen! I don't think these people understand what it is going to do to our ecosystem and to folks who live near those habitats! It is dangerous to their children and their families!"

- Students will read statements and paste into chat
- Participants will each take a turn to practice drawing outkey values, interests, and goals
- Then, each participant will ask a question that opens up the conversation
- 15 minutes in breakout groups

PRACTICE

- Round One: Students will first model facilitation behaviors by leading a discussion about Approach 1 in the Climate Choices NIF Guide
 - Trainees will participate as if this is a normal event
- Round Two: participants will practice facilitating the same Approach with "difficult participants". Played by students (and others in the group who are willing!)
 - Practice paraphrasing, referring to ground rules, etc.
- Students will debrief and provide feedback
- 10 minute model facilitation, 20 minute practice facilitation
